- (iii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Regulation Norms & Procedure) Regulations 2014.
- (iv) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in Position.
- Further the recognition is subject to the condition that the institution shall move gradually to become a composite institution but not later than 2016-07.
- Further, the recognition is subject to fulfilment—of all such other requirements as may be prescribed by other regulatory bodies like UGC affiliating University / Body; the State Government etc., as applicable.
- 4. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 5. - Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information. If it so desires.
